 - Increase to Capital Facilities and Technological needs fund
 - Expansion of Stigma and Discrimination Reduction program
 - Expansion of suicide prevention program
 - Elimination of FSP Engagement as a separate project
 - Michael Fields commented that he applauds BHS for its Peer Navigation program, and is confident that Telecare will do a great job.
- MHSA Community program planning is scheduled to begin in January.

- Michael Fields, NAMI President
 - Peer Recovery Services was awarded a Dignity Health grant to open a satellite Wellness Center in Manteca.
 - It will be a peer run, non-clinical, 18+ program
 - Kudos to VCCS, reported positive experiences when working with that agency.
 - NAMI offers the following groups in many locations throughout San Joaquin County:
 - Family to family,
 - o Connections,
 - Peer to peer,
 - o Spanish, and
 - Provider Education

VII. DIRECTOR'S REPORT

- Thank you to Michael Fields, for the presentation on NAMI. Thank you to all staff and partners,
- Tony discussed year-end highlights for all departments.
 - 24 Hour services: Received over 3,200 hospital field calls, 17,800 warm line calls, and 2,300 CSU admissions were discharged to a lower level of care. Mobile Crisis Response team responded to 803 incidents, only 14% resulting in psychiatric holds.
 - Adult and Older Adult services: over 6,300 clients received outpatient mental health services, with an average of 29,000 services provided each month, 5 new homes were opened by Progressive Housing, 22,600 services provided by the CATS Nursing Team, La Familia and BACOP are relocated to the main campus.
 - Children and Youth Services: Over 2,400 youth were provided with mental health services,
 76,900 direct client services were provided, the CARES program received 400 referrals, 560
 youth received crisis evaluations, and 239 presumptive transfers were received.
 - Justice and Decriminalization Division: The LEAD program served 55 individuals. The Assessment and Respite Center at Community Medical Center has been in operation for over a year and has doubled the projected number of individuals expected to receive services. 125 individuals contacted by the Whole Person Care Team



- Substance Abuse Services: Established the BQuip Substance Use Disorder phone screening, redesigned the intake process to accept walk-in and scheduled appointments, continued to implement the Drug Medi-Cal Organized Delivery System (DMC-ODS).
- Quality and Performance Improvement: Over 5,500 calls were received by Access, 947 out of county hospital chart were reviewed, coordinated the first SUD External Quality Review, certified four new adult outpatient programs,
- Administration/Finance: Received a \$2.5 Million CHFFA grant, held 2nd Annual MHSA Showcase, hired a new Facility Supervisor, a Contract Supervisor, and a new Finance Deputy Director. Finance implemented new efficiency standards and closed the fiscal year earlier than ever.
