### IV. PRESENTATION

#### A. Inspire and Laura's law

### - Frances Hutchins, Assistant Behavioral Health Director

The Implementation of the Lanterman-Petris-Short (LPS) Act permits involuntary mental health treatment when, due to mental illness individuals are a risk to themselves, or others, or cannot provide for their basic needs. Holds can range from short term for 72 hours, extended for 14 days, or conservatorship for up to one year. Statewide there has been low rates for those leaving involuntary holds and connecting to Assisted Outpatient Therapy (AOT). BHS has a high risk transition team and Peer Navigation team with Telecare, and Peer Navigation Services with Telecare. In 2011 BHS established the Inspire program as an intensive voluntary program that is an alternative to court ordered AOT. The services are voluntary but the staff provides extra motivation and encouragement to engage participants in services without court ordered interventions. Counties are required to offer AOT as of July 1, 2021 unless the Board of Supervisors passes a resolution to opt out, and includes reason for opting out.

The California Behavioral Health Planning Commission's Data Notebook was discussed. The survey included questions regarding Adult Residential facilities bed numbers, number of Institutions for Mental Disease, Homelessness programs and services, Foster Care youth in Group homes, response to COVID-19, and Telehealth.
